Procedure to Resolve the Complaints in Grievance Redressal Committee

- 1. Firstly, the Grievance Redressal Committee enters the grievance honestly to its register as soon as it receives the grievance or any notice of non-satisfaction from any grievant in the college.
- 2. Secondly, the Committee will categorize and analyze the grievances received in terms of the college general administration. From the Head of the Committee, the grievance is forwarded to the respective department with a request for a response.
- 3. The committee will monitor whether the grievance has been redressed by the respective department.
- 4. The head of the committee will appoint a day for hearing by interviewing both the grievant and the staff.
- 5. The committee will ensure that the grievance is redressed by the staff by having the grievance redressed by the grievant.
